Topic: "Energy Efficiency in Commercial Buildings

R. Christopher "Chris" Mathis has spent the past 30 years focusing on how buildings and building products perform – from energy efficiency to code compliance to sustainability and long-term performance durability.

Chris is an active participant in Standards and Code development at ASHRAE, NFRC, ASTM and the ICC. He was a founding member and served for four years as the first Director of the National Fenestration Rating Council, the non-profit organization that developed the nation's energy performance rating and labeling system for windows, doors and skylights.

Chris has been a member and active participant in ASTM committee E06 on Performance of Buildings since 1984. During his tenure at ASTM he has worked on numerous task groups and subcommittees developing a range of standards and test methods addressing window performance, window installation, thermal testing of windows, wall system performance and whole building performance. He currently chairs E06.51.11 addressing window installation standards. He is also a member of committee C16 on Insulation and E60 on Sustainability. Chris currently chairs the Built Environment Advisory Committee at ASTM.

Chris is a 30-year member of the American Society of Heating, Refrigerating and Air Conditioning Engineers (ASHRAE). In ASHRAE he has worked on window thermal test standards, national model codes for commercial buildings (ASHRAE 90.1), model codes for residential buildings (ASHRAE 90.2) and is the energy consultant to Standard 189.1 – ASHRAE's model code for sustainable commercial buildings. He is also the energy consultant to the Chapter Technology Transfer Committee. Chris has been recognized as an ASHRAE Distinguished Lecturer, conducting seminars on a variety of building science, energy efficiency and sustainability topics across the US and worldwide.

Chris has published numerous technical papers at ASHRAE and presented his work at a variety of national and international conferences. His publications include technical papers on: advanced test methods for insulation materials and wall systems; daylighting design and assessment techniques; off-peak cooling techniques for commercial office buildings; new residential and commercial energy codes; and metrics for environmentally preferable products. He has written numerous engineer-, architect-, builder- and consumer-targeted articles and guides on various building and product performance issues. He is the author of *Insulating Guide* - a book for home builders providing insulating best practices for many of the most common home building details. He is the co-author of *Is Your Home Protected from Water Damage? A Homeowner's Guide to Water Damage Prevention* published by the Insurance Institute for Business and Home Safety.

Chris has been involved in state and national code development since 1988. He was selected four times to serve on the International Energy Conservation Code Committee of the ICC, working to refine and improve the IECC – our national model energy code. He was also selected to be a member of ICC's Sustainable Building Technology Committee helping to draft a national model code for sustainable buildings. He served on the ICC's first Code Development Committee for the International Green Construction Code.

Student Activities - Carl McGartlin

Rob Turner, past Charleston Section ACE Chairman, Eric Crawford and Carl McGartlin were all mentors in the local ACE program this past year. Rob Turner has been instrumental in helping the Chasn Section grow and expand into multiple schools over the past four years. At our November meeting Rob will provide an overview of his involvement in the ACE program and how he sees it affecting the lives of high school students.

ACE Mentors of Greater Charleston is part of a national mentoring program which mentors high school students in (A)rchitecture, (C)onstruction, and (E)ngineering as it relates to building construction. It started at Burke High School three years ago, and has expanded into other schools. After three years, we have concentrated efforts on programs at Stall High in North Charleston, and St. Johns High in Johns Island. Stall High had an incredibly successful year last year. The purpose of ACE is to introduce students to the ACE disciplines where they may not have had access to experience or guidance in those fields. High School students may never be advised exactly what an Architect or Structural Engineer does, how a building is built, or how a Mechanical Engineer designs air conditioning for a building. ACE's goal is to put higher numbers of diverse students - who are eager to learn - into college programs in the ACE disciplines by helping them answer these type questions at an earlier age. Students are enrolled in a semester long program which covers the entire construction process from concept to final construction. The students usually develop a "design and build" project towards the end of the program. At the end of the program there is a banquet where the students present their projects to the parents and community members. At this banquet, ACE gives scholarships to (1) student at each school who achieves the best performance and essay scores. This is a key period for ASHRAE, as we delve more fully into engaging with state, provincial, and local officials. It is vital that we build a network of active engineer-advocates worldwide to impress upon decision-makers how their choices will impact society – and HVAC&R professionals specifically – in the days, months, and years to come.

This is a new and important committee for ASHRAE that will coordinate the dissemination of grassroots level governmental activities and related information to members. By understanding what is going on locally, the GGAC can provide the high quality and readily available tools to train and enable chapter members to effect positive interactions with government entities, especially in the use of ASHRAE documents and the advancement of the ASHRAE public policy agenda. This will allow the chapter to position the government adoption of ASHRAE developed and endorsed standards, guidelines and positions.

The GGAC is a resource to help inform our members and local government officials about ASHRAE. ASHRAE has over 53,000 members from over 132 nations. Since 1919, ASHRAE has supported research to improve the quality of life. ASHRAE Research impacts the industry by improving the way HVAC&R systems work, how they are applied and allow development of technical information to create standards and guidelines, which serve as the basis for testing and design practices around the world.

The Society funds thousands of projects addressing topics such as sound, duct design, the effect of oil in refrigerants, load calculations, thermal conductivity, simplified energy analysis procedures, weather data, refrigerant property data, fire and smoke control and solar design. The most significant ASHRAE research is in the areas of human comfort and the properties of materials and systems used in buildings and refrigeration systems.
